Announcement of UG admission under CIWGC, PIO/OCI/FN and NRI.

Instructions for Admission through online application and Counselling to First Year of Under Graduate Technical Courses in Engineering and Technology for CIWGC, PIO/OCI/FN and NRI candidates at Walchand College of Engineering, Sangli for the Academic Year 2024-25.

1. Fifteen percent (15%) seats in the institution shall be allowed on supernumerary basis from amongst Non-Residential Indian (NRI) / Persons of Indian Origin (PIO)/ Overseas Citizen of Indian (OCI) / Foreign Nationals (FN) and Children of Indian Workers in Gulf Countries (CIWGC) over and above of the approved intake of each discipline as sanctioned by DTE, Government of Maharashtra from time to time.
2. The 1/3rd of the 15% sanctioned seats are reserved for CIWGC in each discipline and 2/3rd of the 15% seats are for PIO/OCI/FN. Provided that, if seats in a course reserved for CIWGC remains vacant, then such vacant seats shall be filled in from the candidates of OCI, PIO or FN and if seats reserved for candidates of OCI, PIO or FN remains vacant then such vacant seats shall be filled from CIWGC. Provided further that, any vacant seat in the above quota may be filled from NRI category. The maximum limit for NRI type is 5% of sanctioned intake.
3. Candidate whose name appears in the confirmation list, declared by the CET Cell, Maharashtra State, Mumbai for Admission to First Year of Under Graduate Technical Courses in Engineering and Technology for CIWGC, PIO/OCI/FN and NRI are only eligible to appear for admission process as per institute guideline to First Year of Under Graduate Technical Courses in Engineering and Technology under CIWGC, PIO/OCI/FN and NRI category at Walchand College of Engineering, Sangli.
4. Candidates have to submit scan copy of Institute Admission application form in prescribed format along with all necessary documents, receipt of processing fee & acknowledgement received after scrutiny of documents by state CET cell Maharashtra to WCE admission cell by email to fyadmission@walchandsangli.ac.in by 24/08/2024 @11.59 PM.

12. Candidate will lose claim to participate in the admission counselling process, if he/she fails to produce ALL the applicable original documents at the time of document verification during counselling round. In case a candidate has taken admission elsewhere, he/she will be required to submit/produce original fee receipt; admission letter generated from CET Cell Maharashtra, collected document receipt and the candidate should submit undertaking stating that he/she will submit original documents within four working days from the date of reporting.
13. These admissions will be made strictly in the order of inter-se merit from amongst the candidates who **report in person** for admission to WCE Sangli against the seats available in various courses at the time when the candidate actually reports for admission by counselling.
14. If a candidate of higher merit reports late during the process of counselling, the candidate may be considered for allotment of a seat available at that point of time for a particular category to which he/she belongs. Such a candidate shall be given preference for

admission above the candidates with lower rank present at that point of time. The decision of the admission center in-charge shall be final and binding to all.

15. All candidates must ensure that all the documents and certificates submitted must be in ENGLISH language only. In case if the document(s) and certificate(s) are in other than English language, the candidate must submit certified translated copies of documents /certificates in English.

Candidates seeking admission to **PIO/OCI/FN and NRI category** are required to pay the requisite Institute admission fee of **US\$ 5000 (in US\$ only)** or equivalent Indian rupees (INR) at the conversion rate at the time of payment + **INR Rs. 31,254/-** through demand draft only, drawn in the favor of “**Director, Walchand College of Engineering, Sangli**” payable at Sangli
18. Candidates seeking admission to **CIWGC category for Aided courses** are required to pay the requisite Institute admission fee in **INR Rs. 86,104/-** through demand draft only, drawn in the favor of “**Director, Walchand College of Engineering, Sangli**” payable at Sangli.
19. Candidates seeking admission to **CIWGC category for Un-Aided courses** are required to pay the requisite Institute admission fee in **INR Rs. 93114/-** through demand draft only, drawn in the favor of “**Director, Walchand College of Engineering, Sangli**” payable at Sangli
20. The candidate who fails to produce the applicable documents in original/submit the requisite fees (application processing fee/institute admission fee in Demand Draft) will not be eligible to participate in the admission process at WCE and such candidature of the candidate will be cancelled at the respective stage of the admission process.
21. After allotment of seat, candidate will be issued an allotment letter duly signed by the Authority of WCE along with the Stamp of WCE. The allotted Course/Branch as per the merit is final and cannot be altered later.
22. No candidate should leave the venue of counselling without the allotment letter duly signed by the authority. The candidate is advised to check the details as printed/written in the allotment letter.

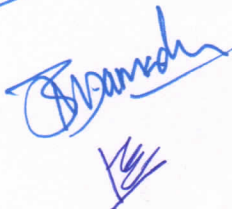

23. The physical presence of candidate at the time of Counselling is mandatory. If a candidate is unable to be physically present for Counselling due to unavoidable circumstances, he/she may authorize his/her parent/guardian to represent him/her for the counselling round. The candidate or the authorized representative of the candidate must carry all the applicable documents in original, Demand Drafts towards Institute admission fee, an Authorization Letter duly signed by the candidate and the representative, and candidate's as well as the parent/guardians Photo Identity card in original. Absence of the candidate or his/her authorized representative at the indicated counselling venue may result in the forfeiture of his/her claim for a seat as per his/her merit rank. The authorization letter will be collected by the admission Convener.
24. In case the parent/guardian representing the candidate, the seat choice made by the parent/guardian will be final and binding on the candidate. No claim will be entertained later on. In case of cancellation of confirmed admission later, admission fee paid by the candidate will not be refunded under any circumstances. Returning of applicable original documents submitted by such candidates at the time of seat allotment will be carried out within one working day after the receipt of request for "**Admission cancellation form**" from the candidate. Such candidates have to apply in the prescribed format (Refer Annexure -II) for cancellation of admission and for collecting the documents candidate will have to report personally with the original Admission Allotment Letter issued at the time of Counselling/Admission as mandatory document.
